

## **The 2nd Annual Sippi Cup - Competition Guidelines**

### **CATEGORIES**

1. Sativa Flower
2. Hybrid Flower
3. Indica Flower
4. Pre Rolls
5. Infused Pre Rolls
6. Vapes
7. Concentrates (Sativa)
8. Concentrates (Hybrid)
9. Concentrates (Indica)
10. Edibles
11. Topicals

- There are 11 categories.
  - Due to Patient Allotments, the number of competitors per category must be limited. Please see the table below for a breakdown of total competitors per category
- Category Sample Size

### **Max Competitors Per Category**

Sativa Flower 1g = 28  
Indica Flower 1g = 28  
Hybrid Flower 1g = 28  
Pre-Rolls 1g = 28  
Infused Pre-Rolls 1g = 8  
Edibles 25mg = 32  
Concentrates 1g = 8  
Vapes .5g = 16  
Topicals N/A = N/A

### **JUDGES**

- There will be 33 judges in total, 3 per category.
- Judges will be selected by the 3MA Events committee - industry professionals with a valid medical cannabis patient card may apply via our website (NOTE - Judges associated with businesses that are competing in specific categories will be ineligible to serve as a judge in those categories, but may be selected to judge another category).

- All Categories will be judged OFF-SITE this year due to increased competitor pool
- Judging consists of 4 ratings; Look, Smell, Taste (application for topicals), and Effect.
- Each rating will be scored from 1 to 5, with 5 being the highest score per rating.
- All scores from both judges are added up for a total score.
- The highest total score wins a first place trophy and first place certificate award.
- The second highest score wins a second place certificate award.
- The third highest score wins a third place certificate award.

## **KITS**

- 33 Judge Kits will be prepared in advance of the event.
- There will be 3 Judge Kits available per category, one for each judge.
- Each Judge Kit is for 1 category and contains all competitor samples
- Competition samples should be packaged using an unbranded 4x4 mylar bag. Sample bags can be provided if needed.
- Competitors will also receive a specific number to correspond to the judge's scorecard.
- The following locations that judges can request their kits be delivered to are:
  1. Southern Sky Wellness - Gulfport
  2. Rootdown - Bay St. Louis
  3. Rootdown - Pascagoula
  4. Southern Sky Wellness - Hattiesburg
  5. Noble Labs Dispensary - Tylertown
  6. Southern Sky Brands - Jackson
  7. Rootdown - Jackson (Old Canton Road)
  8. Southern Sky Wellness - Tupelo
  9. Southern Sky Wellness - Vicksburg
  10. Southern Crop - Olive Branch
- Judges may request that their judge kit be made available at a different dispensary for convenience, but must make this request NO LATER than March 12th, 2025
- Competition samples will be pennied-out to the judges. Total costs for kits will vary based

on competitor pools per category, but should remain under \$.50 per kit.

## **COMPETITORS**

- Entry without event sponsorship - \$250/each per category
- Entry with event sponsorship - \$100/each per category
- One entry per company per category
- Flower entry to provide (five) 1 gram packages, for a total of 2 grams.
- Pre Rolls entry to provide (five) 1/2 gram packages, for a total of 1 gram.
- Infused Pre Rolls entry to provide (five) 1/2 gram packages, for a total of 1 gram.
- Vapes entry to provide (five) 1/2 gram packages, for a total of 1 gram.
- Concentrates to provide (five) 1/2 gram packages, for a total of 1 gram.
- Edibles to provide (five) 25 mg packages, for a total of 50 mgs.
- Topicals to provide (five) bottles/containers with black tape covering all labels/artwork.
- All transportation is provided by Falcann.
- All products must be available for transport on or before Tuesday April 1st 2025. (the earlier the better)
